# **UPMA Membership**

 All UPMA National Executive Board leaders, State Presidents and Executive Vice Presidents are active employees just like you, using and working through everyday circumstances except for Retiree Officers leading the retirees. UPMA mentors craft employees to succeed us as new EAS.

# NAPS Membership – "Most National officers are retired."

 Most have no idea of what is transpiring daily at work because they have been retired and have no skin in the game when they finish their terms as they won't be coming back to work. NAPS do not mentor craft employees because they do not have that classification as a member.

# Representation Comparison for Adverse actions against members <a href="UPMA">UPMA</a> vs <a href="NAPS">NAPS</a>

- UPMA represents any EAS member the second they sign up.
- To be eligible for AALDP benefits, you
  must be an active EAS member of UPMA for
  at least one year prior to the date of an initial
  proposed adverse action. The date UPMA
  National Office processes a Form 1187
  determines the Member's effective date.

### Adverse Action Legal Defense Plan (AALDP)

- EAS with MSPB Appeal Rights:

• To be eligible for representation through the DDF, an active member must meet the following criteria: "(a) the active member must have signed an application for NAPS membership sixty (60) days from the effective date of promotion from the craft, or "(b) the active member must have been a NAPS member no fewer than ninety (90) days prior to the charge being issued.

### The Disciplinary Defense Fund (DDF)

- The Disciplinary Defense Fund (DDF) was established by the membership, for the membership, to provide representation for NAPS members in appealing adverse actions, RIFs and debt collection actions taken against them. NAPS is a professional organization of supervisors and managers (as opposed to a union).
- Under this classification, <u>NAPS is not</u>
   <u>obliged to defend every member</u>,
   <u>regardless of the charges they may face</u>.

### <u>UPMA</u> vs <u>NAPS</u>

If attorney fees are awarded by a percentage (i.e. 50%), the same percentage will be used when refunding the members used portion of their retainer.

# Reasons UPMA is growing at a rapid pace.

- If fees or expenses incurred for the defense are expected to exceed the \$3,500 limit, the Labor Relations Admin Group, LLC will notify you, in advance.
- No additional fees or expenses will be incurred for my representation without my authorization.
- If I do authorize additional fees and expenses, I will be personally liable to the provider for these additional expenses.
- In the event the MSPB should award any payment for my legal fees, it is understood that the monies will be used to reimburse the NAPS DDF for monies expended for my representation by Labor Relations Admin Group, LLC to the extent possible under the award.





### UPMA has been instrumental in securing or solely responsible for:

- Postal Reform only management organization of employees that marched on the hill for reform.
- 3% raise mostly attributed to the PMG and Doug Tolino due to Postal Reform
- 3% raise applied on 9/24/2022 prior to end of FY.
- Pay Band upper-level increase of 4.1% 1/14/2023 input prior to the 2023 NPA pay out.
- Pay Band upper-level increase of 4.7% input prior to Jan 2024 NPA pay out.
- Special Exempt pay for carrying mail when all other options contractually have been exhausted.
- Special Exempt pay during COVID.
- Pay Band differential pay increases for those moving up several steps at a time.
- NPA /PFP input to regulate what we have control over and 10-point scale.
- Actual NPA percentage increase that matches the cell you are in through cell 8
- Leave carryover amount increased during COVID for FY22 and FY23 which now is permanent.
- SALARY RANGES.
- **MODIFICATION TO POSITION UPGRADES** Position Upgrade will be modified, and the current 2 percent basic salary increase for position upgrades will be increased to 4 percent.

### UPMA has been instrumental in securing or solely responsible for: (continued from previous page)

- MODIFICATION TO PROMOTION INCREASE 3% to 4% minimum plus additional increases depending on how far away from the top end of the scale promoted to.
- SUPERVISORY DIFFERENTIAL ADJUSTMENT (SDA) A new position group, Customer Services was established that included Postmasters Grade 18 and Grade 18B among the group and minimum salaries of those Postmasters will be at a rate of 5% greater than that of a City Carrier at RSC Q, Step 0.
- Effective November 20, 2021, the minimum salary for the EAS-20 salary schedule/ grade will be increased to \$74,000 now much higher.
- Level 20 Postmasters that are not authorized a supervisor are eligible for EAS Additional Pay through the duration of the pay package.
- Level 18 WSC (Workload Service Credits) split in to two categories EAS 18 and EAS 43
- UPMA secured saved pay grades for Postmasters and Station Managers where their carriers were
  moved into an S&DC.
- **UPMA meets with the CRDO biweekly** and has achieved now a ratio of city carrier to route ratio of 1.5 and is currently working on the workload to clerks to adjust to meet loads.

# **Changes to NY State UPMA ByLaws**

### - to be voted on at State Convention

# BYLAWS OF THE NEW YORK CHAPTER OF THE UNITED POSTMASTERS AND MANAGERS OF AMERICA, INC. Adopted June 18<sup>h</sup> 2023 Preamble

The purposes for which this Chapter is organized as a part of national organization, United Postmasters and Managers of America (UPMA), shall be to provide a vehicle through which members may assist one another in matters connected with their employment in the United States Postal Service; to foster a favorable image of public service; to; assure the users of the mails the best service possible improve the conditions under which individuals work, having concern for salaries, hours of employment, working environment, and related issues; to cooperate with other groups and levels of postal management in the achievement of common goals.

### Article I - Name

This organization shall be known as the New York Chapter of the United Postmasters and Managers of America Inc.

### **Article I Section 1 Subordinate units**

The subordinate units of this organization shall be known as Districts, which are a make-up of County or Multi-County Associations.

### Article II – Purpose

The purpose of this organization shall be to affiliate with and become a part of the national UPMA organization.

### Article III – Membership

Any person as designated by the UPMA Governing Documents to be a member of the national Organization shall be considered a member in this Chapter but no member in arrears for dues shall be recognized or permitted any of the privileges at its conventions.

### Article IV - Meetings

The annual convention of the organization shall be held at the time and city as set by the "annual convention one year or more prior to that convention," provided however, that the president may, with the approval of the majority of the executive board, and for good and sufficient reason change the time and or place previously fixed. All chapter conventions must be completed prior to the start of the National Convention.

Special meetings may be called by the president and shall be called on the request in writing by a majority of the executive committee or on demand in writing of ten (10) percent of the paid-up membership of this chapter.

The chapter secretary/treasurer shall mail notice of meetings to members of the executive committee at least ten (10) days prior to the date specified for such meetings or <u>5 days electronically</u>.

In any convention of this chapter, all members who are present and registered for the convention shall constitute a quorum.

Robert Rules of Order shall govern the deliberations of this chapter except where any provisions of this Bylaw document are inconsistent or in conflict with Robert's Rules of Order; then, this Bylaw document shall prevail.

### **Article V- Election of Officers**

The officers of this chapter shall be a president, executive vice president, a secretary/treasurer, the immediate past president (who shall serve for a term of two years beginning at midnight the day after close of the National Convention and will end at midnight the day after the National Convention closes of the year a newly elected president shall assume office), the president of the UPMA retired, who together with the four vice presidents, shall constitute the executive committee, and the governing body of the chapter. The president shall be elected at the annual convention to serve a term of two years. Three vice - presidents which will be the Executive Vice President, PAC VP and Educational VP shall be elected the same year and serve a term of two years. The vice presidents of Adverse Action and Legislation along with the Secretary/Treasurer shall be elected at the annual convention in a subsequent year to serve a term of two years. The term of office shall commence the following day after close of the National Convention and will end at midnight the day the National Convention closes. The position for which an officer is elected shall be limited to two consecutive terms of office. Vice President (VP) positions will be voted on by specific position title as Executive VP Membership, VP Educational, VP PAC, VP Chapter Member Representative and VP Legislative.

If there are no candidates for a position the current officer will remain in office until the next state convention election turn over date or appointment by the Executive Board is made.

# In the event a State Officer retires or leaves the USPS during the final year of their term, they may remain on to fulfill their term.

If in any year the State Convention is held and officers are elected and the National Convention is cancelled, all elected officers will take office the following day the National Convention would have ended. If the State Convention is cancelled all officers will continue until the next State Convention in which all elected officers take office according to the above paragraph.

### **Article VI District Coordinators**

District Coordinators will serve the districts that currently exist according to the District Map and be nominated and elected for two-year terms every odd year and be sworn in. They will take office at close of the Swing meeting elected at. District Coordinators are not voting members of the Executive Board but will be required to attend the three Executive Board meetings for member information and audit purposes which are the Executive Board meeting held within the first 120 days of office and pre and post-convention boards. District Coordinators that can't attend an Executive Board meeting should designate an alternate representative for them. District Coordinators should entice and work with the County Officers to set up District meetings.

- (a) Confer with the Vice President that will serve as the Chapter Member Representative Chair on matters pertaining to their respective Districts.
- (b) Contact all county and multi-county organizations periodically by attendance at county meetings.
- (c) Call a district meeting at least twice a year for the purpose of advising the district membership of progress within the state and for maintaining communications. between the counties and the state
- (d) Assist the members in their districts in all endeavors.
- (e)Attend all meetings required by the President.

# Article VII REPRESENTATION & VOTING AT STATE CONVENTION

Voting will be done by one vote per active member present, with the exception of Time and Place and Dues structure where all members present can vote.

All members must be registered and present at the Convention to be considered to be nominated and voted on for any position. Any exception to this rule must have had an announcement published in the ESUPMA or a letter to the President emailed or hand delivered by them as their intent to run prior to the start of the Convention.

Additional or other nominations shall be made from the floor, if seconded and approved, and shall be included with the list of recommendations made by the nominating committee for determining by ballot, of those present and

qualified to vote in said election. If there shall be more than two nominations for any office, balloting shall continue until one candidate receives a majority of the votes cast.

If there is a tie vote for any position, the position will be decided by a separate Executive Committee session where a majority vote will decide. If there still is a tie after this the President or (Executive Vice President if in the capacity of acting President) will cast the deciding vote.

With the exception of the positions of President and Executive Vice President, which shall be limited to active EAS members in good standing of the organization, retired Postmasters, retired EAS employees and Postmaster Reliefs shall be permitted to hold office in this chapter provided they are present at the meeting where the vote will be taken and that no other active EAS member seeks the office. Any active member who is an officer of this chapter, who during their term shall resign or be removed for any cause whatsoever, from the position that qualified them for active membership, shall immediately become ineligible to hold office and their office shall be declared vacant. If there are no candidates to elect for the position of President or Executive Vice President and the position or positions are vacant the Executive Board will appoint a candidate or share the responsibility until the position can be filled.

If the Executive Board elects to have an Electronic or mail in option as well as in person, procedures for that will be followed as set up by the Executive Board.

### **Article VII Section 1**

State convention registration fees charged UPMA Retired members shall be twenty-five percent (25%) less than such fees charged active Postmasters and guests and shall include all functions included for active Postmasters and guests.

### Article VIII - President

The president shall preside at all meetings of the chapter, shall call special meetings when requested to do so as provided in Article IV. They shall also preside at the meetings of the executive committee and appoint all committees for the proper handling of the business of this chapter and in general perform such duties as may pertain to the office. The president shall receive such compensation for their services as the executive committee may provide. The president shall be bonded as provided in Article XVI.

### **Article IX – Executive Vice President**

The executive vice president shall serve in the absence or disability of the president and work with the president as needed. This position will be voted on as the Executive VP, be a two-year position and must be an active member. Should the office of the president be vacated, the executive vice president will serve the remaining term. The remaining term of the vacant position of the executive vice president shall be filled by the executive committee. If there is no Executive VP to fill the position the Executive Board will appoint someone to fill the President's position or share the responsibility until the position can be filled.

In addition, the executive vice president shall serve as the Membership Chair for the chapter. It shall be their duty to promote membership for the organization and ensure that the chapter always has a strong membership. The executive vice president shall receive such compensation for their services as the executive committee may provide.

### **Article X – At Large Vice Presidents**

The At Large Vice Presidents will be responsible for the following duties:

One Vice President will serve as Education Chair. It will be their duty to work with the President in aligning training that is deemed necessary and appropriate for the membership.

One Vice President will serve as the Legislative Chair. It will be their duty to handle legislative activity within the chapter.

One Vice President will serve as the Political Action Committee (PAC) Chair. It will be their duty to handle any PAC activities within the chapter.

One Vice President will serve as the Chapter Member Representative Chair. It will be their duty to work with all Chapter Member Representatives to properly represent the members and to assist the District Coordinators with their labor management concerns.

In the event of a vacancy in the vice-presidential position, the vacancy shall be filled by the executive committee.

### Article XI – Secretary-Treasurer

The secretary-treasurer shall combine the office of secretary and treasurer and shall perform all duties commonly incident to both offices. The secretary-treasurer shall be bonded as provided in Article XVI hereof and shall receive such compensation for their services as the executive committee may provide. The secretary-treasurer shall keep all records, record the proceedings of all conventions and meetings of the executive committee, deposit, withdraw and have custody of the funds of the chapter and shall be responsible to keep an accurate and complete account of the receipts, vouchers and membership. In the event of a vacancy in the position of secretary-treasurer, the vacancy shall be filled by the executive committee.

### **Article XII State Communication**

Section 1: Editor

An editor shall be appointed by the executive committee. It shall be the editor's duty to publish the official newspaper ESUPMA (Empire State United Postmasters and Managers of America) of the NY Chapter of UPMA.

Section 2: Webmaster

A Webmaster shall be appointed by the executive committee. It shall be the webmaster's duty to keep the official website of ESUPMA (Empire State United Postmasters and Managers of America) of the NY Chapter of UPMA current.

### Article XIII - Executive Committee

The officers of this chapter shall be a president, executive vice president, four at large vice presidents, a secretary-treasurer, the immediate past president who shall serve a term of two years beginning the following day after the National Convention of the year a newly elected president assumes office and the president of the UPMA Retired shall constitute the executive committee and the governing body of the chapter.

It shall be the duty of the executive committee to carry out the orders of the chapter as expressed in the convention, it shall have direct control of all business of the chapter and its affairs, it shall be the power of the executive committee to authorize necessary expenditures; to audit all accounts; approve the expenses of the executive officers and in general perform all the functions ordinarily attached to such committee.

The executive committee shall have the power to remove any of the States elected officers for good and sufficient reason by two-thirds vote of the committee. The President shall have the power to remove members in appointed or non-elected positions.

In case of vacancy of the Immediate Past President, the office shall remain unfilled until the next Past President is available.

In case there are equal number of voting members on the Board, a tie vote on any matter is considered defeated except as described in Article VII.

"Honesty is the fastest way to prevent a mistake from turning into a failure." James Altucher In today's Postal Service that statement couldn't be more true or relevant . As a National Member Representative, I've had a number of cases that dealt with integrity issues. It can start as an ordinary day in which you are shorthanded, or as the day develops, you realize that you are going to have trouble delivering all the mail in your unit. Unfortunately, in some of those cases, the manager has chosen a shortcut due to a difficult situation. Possibly it's misrepresenting the number of parcels delivered or the time in which carriers

They succumb to the pressure and falsify records. With the current Postal Service technology, it is difficult for these situations not to be discovered. As a member representative, part of my job is to help managers avoid discipline which can result in serious injury to their careers and employment.

My advice to all managers is to recognize when you know your day may not end well and to inform your POOM of your situation.

If you have any indication that you may not be successful on any given day, the earlier you inform your Poom that you have a situation, the better.

> You should definitely communicate the possibility of your worst case scenario. This way, there will be no surprises at the end of the day. It also gives the POOM the

opportunity to possibly send you the resources you need. If you finish earlier than you predict your day will then be deemed a success.. When a manager makes the decision to falsify records or fails to report undelivered parcels, and it is realized that that was done the resulting discipline could be devastating or career ending. It is much easier to defend the inability to perform than it is when your lack of integrity is the center of your discipline. Honesty always is the best

# CONGRESSIONAL BILLS REGARDING WEP AND GPO WHAT ARE THE DIFFERENCES

The Government Pension Offset (GPO) and the Windfall Elimination Provision (WEP) have for decades limited Social Security payments available to certain federal employees; mainly those under the old Civil Service Retirement System and anyone else who receives a pension from earnings that were not taxed by Social Security. A bill to repeal GPO and WEP had a Congressional hearing last month at a field hearing in Louisiana. It has taken time to bring this issue to the attention and action by our Representatives in the House and Senate, but now there are more than one bill in the House and the Senate. Following I will try to explain what the Bills are and their differences.

I will start with the more widely known bill:

H.R. 82/S.597 Social Security Fairness Act introduced in the house by Reps Garret Graves, R-LA, and Abigail Spanberger, D-VA that has bipartisan support. This bill would fully repeal the WEP and GPO. Senate companion bill is S.597 introduced by Sherrod Brown, D-OH and Sue Collins, R-ME

H.R. 82 Co-Sponsors 205 -D 106-R T 311 S.597 Co-Sponsors 41-D 9-R 3-I T 53

H.R. 4583/ S. 2280, Social Security 2100 Act, introduced in the House by Rep. John Larson, D-CT, and in the Senate by Sen. Richard Blumenthal, D-CT, would fortify the Social Security program and expand benefits. Most notably, the bill would fully repeal the WEP and GPO. In addition, the bill would increase the average Social Security benefit, improve cost-of-living adjustments, index Social Security to wage levels, and more. As it would repeal WEP and GPO,

extend the solvency of the Social Security trust fund, and improve Social Security benefits in other ways, by applying FICA to earnings above \$400,000, with those extra earnings counted toward benefits at a reduced rate and receiving a lower rate on investment income by adding a 12.4% net investment income tax (NIIT) only for taxpayers making over \$400.000.

H.R 4583 Co-Sponsors 183-D S-2280 Co-Sponsors 4-DT4

H.R. 4260, the Public Servants Protection and Fairness Act, introduced by Ranking Member of the House Ways and Means Committee, Richard Neal, D-MA, would provide some relief from the WEP for both current and future retirees. While the legislation does not fully repeal the WEP, it represents a significant improvement over the status quo for CSRS retirees unfairly penalized for their public service. Specifically, the bill would do the following: • Individuals turning age 62 before 2025: Under the bill, individuals receiving WEP-reduced Social Security benefits based on their own work record would receive a rebate of \$150 per month.

Individuals turning age 62 in 2025 or later: These individuals' WEP penalty would be subject to either a new formula or the current formula, whichever provides a higher benefit. The new formula would calculate benefits based on the proportion of a worker's career earnings in Social Security-covered jobs to total earnings in covered and non-covered jobs.

H.R. 5342, Equal Treatment of Public Servants Act of 2023 introduced by Rep. Jodey Arrington, R-TX, would reform the Windfall Elimination Provision (WEP) would provide relief from WEP for both current and future retirees. While this legislation does not fully repeal the WEP, it represents a significant improvement over the status quo. Specifically, the bill would do the following: • For individuals who are first eligible for Social Security benefits before 2025 (turning age 62 before 2025): Under the bill, individuals receiving WEP-reduced Social Security benefits based on their own work record would receive a payment of \$100 per month. Meanwhile, spousal and child beneficiaries receiving a WEP-reduced Social Security benefit would receive a payment of \$50 each month. • For individuals who are first eligible for benefits between 2025 and 2067 (turning age 62 in 2025 through 2067): These individuals' WEP penalty would be subject to either a new formula created by the bill or the current formula, whichever is more beneficial. The new formula would calculate benefits based on the proportion of a worker's career earnings in Social Security-covered jobs to total earnings in covered and non-covered jobs. • For individuals who are eligible for benefits starting in 2068 (age 19 and under in 2025): These individuals' WEP penalty would be calculated with the new formula only.

H.R. 5342 C0-Sponsors 1-D, 28-R T29

H.R. 1046/S393 Social Security Expansion Act introduced in the House by Schakowsky D-ILL and introduced in the Senate by Sanders, I-VT

Changes to benefits include (1) increasing the primary insurance amount for certain beneficiaries; (2) revising the method of calculating cost-of-living adjustments; (3) establishing a new minimum benefit for certain low earners; and (4) allowing

certain children of retired, deceased, or disabled workers to receive benefits until age 22 if they are a full-time student. Changes to taxes include (1) increasing the net investment income tax and making active trade or business income subject to this tax; and (2) extending payroll taxes on wages, salaries, and self-employment earnings to income above \$250,000 (the maximum amount subject to the Social Security payroll tax is currently \$160,200 for 2023). The bill also combines the existing Federal Old-Age and Survivors Insurance Trust Fund and the Federal Disability Insurance Trust Fund into a single Social Security Trust Fund.

H.R. 7084 you earned it, you keep it-Craig D-MN

On January 25, 2024, Representative Angie Craig, D-MN, introduced the "You Earned It, You Keep It Act," H.R. 7804, which seeks to enhance America's seniors' financial stability while contributing to the nation's fiscal health. The "You Earned It, You Keep It Act" proposes eliminating all federal taxes on Social Security benefits starting in 2025, a move designed to significantly increase retirees' disposable income.

The act suggests increasing the Social Security payroll tax cap for higher-income earners to support this tax elimination. This means individuals earning more would contribute more to the Social Security fund, ensuring its financial health and sustainability. An <a href="mailto:analysis">analysis</a> indicates that this move could extend the solvency of Social Security payments through 2054, twenty years longer than current projections, and would also reduce the federal debt by \$8.9 trillion over 75 years. H.R. 7804 co sponsors 8 D R T8



The Tunnels to Towers (T2T) Foundation has been selected for this year's veterans outreach program. We are asking you to recommend to your executive boards and individual members to donate to this worthy charity for veterans. Many states have stepped up in the past and made generous donations for our selected veteran's projects. Please consider that for this year's effort to honor and support veterans. \$7000 from last year's program will be donated along with any donations collected this year.

I am Steve Vanderhoof and was honored to be asked to be the chairman of the veteran's recognition and outreach committee. Articles will be written and published in all our publications to explain the process to donate for UPMA to be recognized for our collective contributions. T2T helps the most devastated injured and widows of veterans and their families with small children. A more deserving charity would be difficult to find.

We thought it should be an organization that has a wider network and greater reach to veterans. Therefore Tunnels to Towers came to mind to appeal to our priorities for our members.

Why Tunnels to Towers? Well, first of all, they are a qualified tax deductible 501(c)(3) non-profit organization. So you get a tax deduction if you itemize your taxes. Better yet, 95.1 percent of all donations are directly paid out to support veterans and first responders and their survivors. That statistic is unheard of in the non-profit world. They have the maximum Four Star rating with Charity Navigator. They provide mortgage free homes to Gold Star (death of a service member on active duty), and first responders families with young children. They build or modify homes for catastrophic injured veterans and first responders. They are committed to eradicate homelessness for veterans. They are building and renovating hotels for homeless shelters for veterans. Some are next door to Veterans hospitals. They are doing things for veterans that no one else is doing.

### AN IMPORTANT REMINDER ABOUT THE OPPORTUNITY TO ENROLL IN MEDICARE PART B NOW UNTIL SEPTEMBER 30 2024

The Special Enrollment Period (SEP) has begun for retirees over the age of 65 to enroll in Medicare Part B without having to pay a 10% yearly penalty for each year over 65. That means if you are 70 years of age and enrolled in Medicare Part B you would be penalized 50% of \$174.40 per month. That would be \$261.60 for a single person per month. I am sure re that the cost of Medicare Part B will increase in 2025. It has each year since have been enrolled in Medicare Part B. If your yearly income is over \$103,000, Medicare Part B will cost more per month.

There are benefits to being enrolled in Medicare Part B. Medicare Part B becomes your primary plan. Examples of coverage Medicare Part B includes are: Primary & Specialist doctor visits, Outpatient Care, Medical equipment,


Ambulances, tests screening, vaccines and Mental health services.
